The Northwest Hills Council of Governments (NHCOG) is issuing this Request for Proposals (RFP) to retain a consultant or consulting team to conduct a transit analysis study for the 21 town region utilizing Transit Planning Section 5311 Federal Transit Administration Funds.

Transit Analysis Study focus is to aid in the development of a coordinated transporation service network serving the residents of NHCOG region and provide a thorough analysis to help address the the current and future transit demands.

The Northwest Hills Council of Governments is seeking a qualified team that includes a Transportation Planner/Specialist, GIS Specialist, and has the capability and capacity to meet the COG's objectives outlined in Section IV of this document.

The Respondent's shall be delivered to the Northwest Hills Council of Governments, 355 Goshen Road, Litchfield, CT, 06759 during normal office hours by no later than **3:00PM**, **August 29, 2024**. Submittals received after this date and time will not be accepted. Section I : General Conditions and Submittal Requirements

General Conditions:

Sealed envelope(s) should be clearly marked: "**RFP #24358, Northwest Hills Council of Governments – Transit Analys Study".** Firms mailing proposals should allow for normal delivery time to ensure timely receipt of their proposals. In the case where the NHCOG office is closed for weather related or some other emergency related circumstance, then submittals shall be due the next day when NHCOG office reopens for business, no later than 11:00 AM on that day. **No fax or e-mail Bids will be accepted**.

Submittal Requirements:

In your submittal, the COG is requesting the following:

- 1. A cover letter signed by the primary firm, binding the firm to all of the commitments made in the proposal. This shall include the prime consultant contact information and all subconsultants. Note: the COG will contract with the primary consultant/firm of the team and all others will be considered subconsultants under the executed agreement.
- 2. The name(s), business address, phone number, e-mail address of firms and individuals proposed to participate in all tasks identified in the scope of work.
- 3. A Project Management Plan that identifies the core personnel and their ability to perform the integrated services as described in the work plan in Section IV. Please include the qualifications of each firm and resumes of all the key personell that would be assigned to this project. Resumes shall not be more than two pages in length.
- 4. Three references for projects/plans of relevant scope giving the name of the project, project period, and project cost. (Include the names of clients, primary contact person, email and phone number.)
- 5. A narrative that outlines the proposed scope of services along with the approach, methodology and process that was used in developing the scope and will be used during the implementation of the scope.
- 6. Proposed timeline

- 8. Fee Proposal for Scope of Services. The project budget is \$52,000. The Fee proposal shall include either a lump sum or hour allocation for each task and an hourly rate and expense schedule. Schedule

All questions must be sent in by August 14, 2023 by 3:00 PM

The COG will develop a short list of candidates based on the stated selection criteria to interview for the project. The short-listed firms will be notified via email and will be provided with sufficient notice of the interview date and time.

Project kick off anicipated mid-October 2024.

Selection Criteria

The selection committee will evaluate the applicants based on the following criteria:

- Thoroughness, creativity and clarity of the proposed work, schedule, and project management plan.
 Proposals are reasonably expected to meet the objectives of this proposal.
- Qualifications and experience of personnel to be assigned to the project team.
- Demonstrated capacity to meet schedule. Ability to provide the services within proposed project schedule time constraints.
- Teams clear understanding of the goals and outcomes of the opportunities and constraints that exist within the twenty-one town region of Northwest Hils Council of Governments.
- Teams experience on similar projects. Preference will be to those teams that have experience specifically with transit data analysis, GIS route mapping, and identification of the mobility needs of the aging and disabled population.

Section III - Project Summary, Goals & Background

Summary:

The NHCOG Transit Analysis Study is funded by Federal Transit Administration Section 5311 Transit Planning funds, CT Department of Transportation funds and local NHCOG match. This study will develop a comprehensive understanding of current transit operational deficiencies, route identification of all transit providers, existing operational funding sources, and ridership trends. The analysis will provide recommendations on future improvements that will streamline services and ridership accommodations for elderly and disabled patrons and work-related trips. There are significant gaps in the existing transit system that result in a growing number of denied trips and a growing need to accommodate current and future work-related travel.

The Rural Independent Transportation System (RITS) Map is shown in Appendix A. The map idenfies which towns are covered by each of the current three RITS providers. This transportation service originated in 2017 utilizing \$10,000 Federal Transit Administration New Freedom Grant Program and is currently supported by Section 5310 Non-Traditional Federal Transit Administration funds.

Goals:

As noted in the NHCOG Regional Transportation Plan, there is a very high degree of latent transit demand in the region which is increasing as the region's population ages. Improvements are needed to increase services, especially to those without other travel options as well as those who choose to rely on transit as their primary means of travel.

The Transit Analysis Study will address:

- Elderly/disabled/low-income unmet needs for transit services
- School/work trips for those without motorized vehicle options
- Improve coverage including days of service/times/geography
- Coordinated transit system throughout the region.
- Marketing plan, system signage, and publicly available information about transit options
- Coordinated/centralized communications and dispatch system
- Future ridership projection within the next 5 years

This study will provide an overall transit service assessment, identification of gaps, regional dispatch network, ridership data (current and projected), regional traffic generator locations, and proposed service improvements (including existing route evaluations)

The study will also provide a comprehensive understanding of what future development can be supported based upon proposed services and funding availability.

The data collected as part of this study will inform and support the development of a coordinated and centralized transportation network.

Background:

The NHCOG region covers approximately 786 square miles and is predominately rural located in the northwest corner of Connecticut with Massachusetts boarder to the north and New York to the west [Appendix A]. It is composed of 21 municipalities with the topography of rolling hills and higher peaks to the north and west. Torrington and Winchester are the two major cities within the region. As noted in the NHCOG Comprehensive

Economic Development Strategy (<u>https://northwesthillscog.org/wp-content/uploads/2024/03/NHCOG-CEDS-Report_FINAL.pdf</u>) 57% of all residents and 60% of all jobs are located in 4 communities: Torrington, Burlington, Winsted and Litchfield which further supports the need for improved work-related transportation services in the 21 town region. The median age withing the region is 51. The median household income is \$87,815. The region has an aging population and, "it is expected that by 2040 the number of individuals over 65 will increase by 62%", which emphasizes the need for greater elderly and disabled transportation services.

The major elderly and disabled transportation providers are:

- Northwestern CT Transit District
- Winsted Senior Center
- GEER Village Dial-a-Ride
- Sullivan Senior Center

Section IV - Scope of Work

The Northwest Hills Council of Governments will establish both a Technical Advisory Committee that will work closely with the Consultant to ensure all interests are considered, proper stakeholders are being engaged and outreach is sufficient. Meeting with the Technical Advisory Committee should be included in the scope of work, along with public outreach/engagement.

- Technical Advisory Committee will include the Transportation Planning Director (Project Manager), Representatives from CT Department of Transportation Bureau of Public Transportation, area transit providers, transit district board members and the Region 1 Federal Transit Administration.
- Additional representatives may also be added to the Technical Advisory Board when appropriate.

The Scope of Work must be a multi-disciplinary approach that will rely on technical assistance from (at a minimum) a Planner/Specialist, GIS Specialist, and possible Market Analyst.

Below is a proposed work plan that has been developed to outline the COG's objectives. <u>The respondent is</u> being asked to develop a formalized scope of services that meets these objectives and is within the allowed project budget of \$52,000.

The emphasis of this project should be focused on Tasks 1-3 and Community Outreach on Tasks 4 listed below. This study is intended to set the stage for more in-depth planning and analysis of transit service improvements to accommodate the growing elderly population as well as the current and future work force travel demands.

The Scope of Services shall describe its approach, methodology, process, and allocated funding for each task.





INSURANCE REQUIREMENTS

Certificate of Insurance: All insurance policies must include a Waiver of Subrogation whereby the insured waives its right to subrogate against the COG, its subsidiaries, employees, volunteers, directors and officers. Proof of proper insurance coverage, Workers Compensation Insurance, Liability and Property damage, and Vehicle Insurance shall be filed with the Northwest Hills Council of Governments Purchasing Agent within 10 days after the award of the bid. The Certificate of Insurance must name the Northwest Hills Council of Governments, 355 Goshen Road, CT, its subsidiaries, employees, volunteers, directors & officers as the "Additional Insured" and filed with the Purchasing Agent prior to commencement of work. Renewal Certificates of Insurance must be mailed to the Transportation Planning Director 10 days prior to the expiration of the required coverage.

NON-DISCRIMINATION

The respondent agrees and warrants that in the performance of the contract pursuant to this solicitation he/she will not discriminate or permit discrimination against any person or group of persons on the grounds of sex, race, color, religion, age, marital status, ancestry, national origin, past history of mental disorder, mental retardation or physical disability or other basis in any manner prohibited by the laws of the United States, the State of Connecticut or the Northwest Hills Council of Governments.

FEDERAL PROCUREMENT

Any procurement made pursuant to a federal award or subject to reimbursement, in whole or in part, with federal funds must comply with the Northwest Hills Council of Government's purchasing procedures, state law, and the applicable Federal Procurement Requirements, including 2 CFR § 200.322 ("Procurement of recovered materials"), 2 CFR § 200.323 ("Contract cost and price"), 2 CFR § 200.324 ("Federal awarding agency or pass-through entity review"), 2 CFR § 200.325 ("Bonding requirements"), and 2 CFR § 200.326 ("Contract provisions").
